THE BOUNDARIES OF MINNESOTA. THE UNITED STATES & CANADIAN BORDER

Part 1 - THIS IS THE FIRST IN A SERIES

Minnesota's northern border is also an international boundary. This boundary was the hardest to determine and took decades for both countries to agree upon. In 1783, America had just won its' independence from England. So representatives of the newly formed United States meet with representatives of the British government in Paris. The diplomats sat down to try and settle the differences between the two nations. This included the problem of where to locate the boundary between British and American lands in North America. First, they must determine the entire boundary; from the Atlantic Ocean to the French territorial claims west of the Mississippi River. Secondly, this area of the country (Minnesota) was so ambiguous; none of the diplomats actually understood the terrain.

According to the Treaty of Paris, the international boundary in the northwest should extend through Lake Superior northward of Isle Royal, the Isle of Phelipeaux to the Long Lake, then through Lake of the Woods to its' most northwestern point and the a straight line due west to the Mississippi River.

Three items in this description are somewhat confusing. First, where is Isle Phelipeaux? Next, which lake is Long Lake? Indeed, even if it is a lake at all. Finally, the Mississippi River is not west of the Lake of the Woods. One of the maps used was drawn in 1755 by John Mitchell, a Doctor from Virginia. His map was based on stories and rumors he had heard about the region, even though he had never visited the area. Four major errors on Mitchell's map that made the boundary placement impractical were; he depicted Lake of the Woods as being oval in shape and the source of the Mississippi as is located in area of Fort Winnipeg. Also, no one knew the location of Isle Phelipeaux or Long Lake. The treaty delegates adopted Mitchell's map and hence negotiated the boundary to the best of their ability.

In 1798, David Thompson, a British surveyor and map maker, was hired by Hudson's Bay Company to locate the source of the Mississippi River. While Thompson traveled only as far as Turtle Lake River he proved that the source of the Mississippi River was not west of the Lake of the Woods.

Prompted by this discovery, British and American diplomats met in 1803 to again discuss the issue of the boundary that had been drawn inaccurately twenty years prior. Hence the new boundary was an altered straight line drawn south from the northwest corner of the Lake of the Woods to the mouth of the Mississippi River. All that remained was for Congress to ratify the new treaty.

But, Congress was not about to ratify the treaty. The reason: the Louisiana Purchase. Now the United States owned land on both sides of the Mississippi River. Congress did not want to take action to set a northern boundary that might decrease the amount of land that United States had purchased from France. Congress delayed ratification in the hopes of obtaining more territory from the British.

Wish List

As usual, we are looking to our members for donations towards some of our larger projects.
